You are required to certify you will have available the sum of \$10,000 for your own expenses for your first academic year at the College of the Sequoias, exclusive of travel expenses. You should also indicate how you will meet your expenses for subsequent years of study if you expect your program to require more than one year. Students who plan to stay in the United States through one summer will need an additional \$1,800 for that three-month period. In computing your expenses, you should bear in mind that students holding student (F) or exchange visitor (J) visas will not be authorized to work except under extraordinary circumstances. Therefore, the applicant should not look to employment, either part-time during the academic year or full-time during the summer, as a significant means of support while at the College of the Sequoias. Under no circumstances are students permitted to work full-time during the academic year. If you are a married student and plan to bring your spouse and children, a proportionately larger amount must be certified on the basis of at least an additional \$3,600 per academic year (\$400 per month) for your spouse and \$1,800 (\$200 per month) for each child. (Note that your spouse may obtain work permission only if you hold a J-1 Exchange Visitor visa, and then **only** for his or her and the children's support. Spouses of F-1 Student visa holders are **not** permitted to work under any circumstances.)

You are also likely to need this documentation to prove to the United States Consular officials that you have sufficient funds. We suggest, therefore, that you make copies of all documents for this purpose.

**Please Note: A Form I-20 or DSP-66 (for the issuance of a Visa) cannot be issued to you until you have been admitted to the College of the Sequoias and have completed this form to our satisfaction and returned it to this office.**
