# 13. APPROVAL TO INCREASE THE MEDICAL CAP FOR MANAGEMENT AND CONFIDENTIAL EMPLOYEES

Mr. Bratsch explained that to align with both full-time CSEA and COSTA bargaining unit members, it is recommended the Board approve an increase in the medical cap for management and confidential employees to \$18,540.00/year – effective with the 2024-2025 medical plan year.

Mr. Perez explained that the District is interested in acquiring one (1) Warehouse/Office Building, at 1233 N Century St. Visalia, CA (APN 081-100-054), which resides in the Visalia Industrial Park to accommodate future expansion of the COS Training Resource Center. Dr. Calvin emphasized the necessity for the Training Resource Center to have its own facility, noting that this move-in ready building represents a valuable investment for the District

# 15. PURCHASE OF REAL PROPERTY (RESOLUTION NO. 2024-18)

Mr. Perez explained that the District is interested in acquiring one (1) 2-Unit Tenant Office/Retail Building, and one (1) fast food restaurant building at 1023-1033 S. Mooney Blvd., Visalia CA (APN 095-112-037, 095-112-038), which resides in the remaining land segment on the COS campus quadrant to accommodate future growth of the District. Dr. Calvin shared that this is the last section of the area where the University Center will be built. He provided a brief update and timeline, noting that demolition will occur in phases. The first phase, set for this fall, involves demolishing the now fully vacated apartments.

# 16. ENERGY CONSERVATION PROJECT AND ENERGY SERVICES CONTRACT (RESOLUTION NO. 2024-19)

Mr. Perez explained that the District has evaluated the benefits of installing a 423 kW DC solar photovoltaic (PV) carport system at the COS Visalia Campus for \$3,097,452. Government Code section 4217.10 requires the Board of Trustees to approve a resolution authorizing the energy conservation project plans and acknowledging the proposed net cost savings of \$11,202,596 over 25 years in order to enter into an energy service contract with the District's approved energy service company.
