**COURSE DESCRIPTION:** Designed for Field Officers who are authorized to carry a tactical rifle. Emphasis placed on AR15/M16/M4 rifles. Successful completion of this course satisfies the legislative training mandate to possess short barrel rifles as specified in PC 33220(b) and the Commission training requirement to possess long barrel rifles as specified in Commission Regulation 1081.

**COURSE REQUIRED PREREQUISITE:** Successful completion of Modules III/II or Basic POST Course.

**COURSE FEE:** *\$150.00 per participant.* Enrollment is on a first-come basis. Please enroll your personnel as early as possible.

Dear Participant:

This letter confirms your reservation to attend our **Firearms/Tactical Rifle Course**, scheduled for **September 12 & 13, 2024**. Training will begin at 8 a.m. and end by 5 p.m. each day. The course will take place at Rankin Field, 20000 Road 140, Tulare, CA 93274.

Participants are advised to coordinate their personal and professional commitments, so the course dates remain clear. The California Commission on Peace Officer Standards and Training (POST) policy specifies we cannot certify course completion for anyone who misses more than 1.6 hours of the total 16-hour course.

The first day of the course will encompass lecture, hands on Tactical Rifle handling and live fire training. The second day of the course will be dedicated to testing and qualifying. Persons who fail to qualify on this course of fire in the testing phase will have one opportunity to take a retest on the same day. Anyone failing the retest must take the entire course again if they wish to pursue certification. This policy is set by POST Regulation.

You will need the following equipment for this course:

- 1) Note taking paper and writing instruments.
- 2) Department issued or approved patrol rifle with sling and three 20 or 30 round magazines.
- 3) 900 rounds of factory ammunition for rifle (minimum).
- 4) Department issued or approved handgun, with duty belt and holster and three magazines.
  - a. No cross draw, ankle, shoulder, or fanny pack style holsters.
- 5) 100 rounds of factory ammunition for handgun.
- 6) Weapons cleaning equipment for rifle and handgun.
- 7) Body armor, wrap around eye protection, and hearing protection.
- 8) Appropriate range attire to include body armor and hat.
  - a. Absent the most extreme conditions, training will take place regardless of the weather so students should have the appropriate attire for conditions.
- 9) Optional items include hydration system, kneepads, elbow pads, and sunscreen.

You will need to bring all items on every day of the course. **We have a limited supply of firearms and leather gear that can be rented to students who do not have such equipment for a rental fee of \$25.00. You must contact COS at the time of enrollment and advise if you will be needing to rent equipment.** Whether you will be renting one of the Academy RTC weapons or using your own, you will need the firearm cleaning kit for the weapon maintenance session at the end of each day at the range.
